The Department

The *Ma in Contemporary Philosophy/Philosophy of Science* is run by the Philosophy Division of the Department of History and Philosophy of Science, that is the top academic unit in Greece for philosophical research, as recorded in international research engines (Scopus, Google Scholar, Web of Science)

The History and Philosophy of Science is an academic field at the cutting edge of contemporary research pursued at major universities around the world. Drawing on different disciplines, it examines the philosophical and historical approaches to science in general, as well as to each of the particular research fields, including the humanities and social sciences, natural sciences, psychology and cognitive sciences, life and medical sciences, mathematics and logic, and the variety of new technologies. Our faculty members include some of the world experts in their field, while several of our professors lead or collaborate in international research projects. We study science as a complex historical, social and cultural phenomenon, and we probe and highlight the conceptual dimensions of scientific practice.

The Department's Curriculum includes a broad range of courses, including Philosophy, History, Cognitive Science, History and Theory of Art, History and Philosophy of Technology, Science-Technology Studies, Museum Studies, et al. Our students acquire a rich philosophical and historical education, which forms the core of systematic knowledge in the humanities, the natural sciences, social sciences, mathematics, technology, and the life and cognitive sciences. Graduates of the Department may pursue advanced research in national and international academic institutions, while they can be employed in any post that requires breadth of knowledge and interdisciplinarity, requires creativity, critical thinking, communication skills, and problem-solving abilities.

The Department is located at the main Campus of the University of Athens: it is quite easy to spot, as it is the very first building upon entering the Campus – full details and directions for reaching the Department are available at <u>https://en.phs.uoa.gr/contact/</u>

The Basics

Courses are taught in Athens by professors from Greek universities, as well as by visiting scholars from international institutions.

The Program is offered **in-person only** and admits up to 30 students per academic year.

The **Program's duration** is a full academic year (12 months – 75 ECTS): two Semesters of courses are followed by a Summer Term, during which students will prepare and submit a Master's thesis.

The **fees** of the Program amount to 2700 €.

The language of instruction is **English**.

The **accreditation** of *The* by the Hellenic Authority for Higher Education (a member of the European Quality Assurance Register) is planned for 2024.

Timeline: Candidates may submit their applications **between May 21 – June 30 2024**. Classes start on the first Monday of October, in accordance with the academic calendar published on the webpage of the MA.

Learning Outcomes

The program offers students a solid background in the study of Contemporary Philosophy, delivers an advanced introduction to Philosophy of Science, and teaches the intellectual skills required for engaging with issues which occupy current research into the perennial problems of philosophy. By the end of their studies, students will have familiarized themselves with the major schools of thought in contemporary philosophy and will have received high-level training in the different fields of philosophical research. Students graduating from the program are expected to be able to conduct independent and collaborative research, meeting all requirements for pursuing doctoral studies.

The Structure of the Program

The Program lasts for a full academic year, running from October 1 to September 30, and consists of two Semesters and a Summer Term. Throughout each Semester, students are expected to take three courses (30 ECTS), and during the Summer Term they will be preparing and submitting their MA thesis (15 ECTS).

Students must be successfully tested in:

• 3 Compulsory courses (total 30 ECTS)

and

• 3 Specialization courses of a discipline (total 30 ECTS),

or

• 2 Specialization courses of one discipline and 1 course of another discipline (total 30 ECTS),

and

• Master's Thesis (total 15 ECTS)

To obtain a diploma of the Program a total of seventy-five (75) credits (ECTS) are required.

Accreditation

The accreditation of *The Ma in Contemporary Philosophy/Philosophy of Science* by the Hellenic Authority for Higher Education (a member of the European Quality Assurance Register) is expected to be accomplished by the end of 2024.

Prospective Students I: Requirements

The Ma in Contemporary Philosophy/Philosophy of Science accepts applicants who hold a BA in Philosophy, or any other field of Humanities or Physical or Social Sciences. Prospective students are expected to demonstrate familiarity with the field of Philosophy, either through their previous studies or other means.

Applicants are also required to provide a Certificate of English language proficiency at level C1 (or equivalent). This language certificate is not necessary for native English speakers or those who have already completed studies in an English-language school or university program.

To be eligible for enrollment in an MA program in Greece, the applicant's BA degree must have been awarded by a university/college listed on the following website: <u>https://www.doatap.gr/national-registry-of-foreign-recognized-higher-education-institutes/</u> If the applicant's university, despite being a recognized institute, is not currently on the list, *Ma in Contemporary Philosophy/Philosophy of Science* will request to be added. However, as this procedure might take some weeks, it is recommended to submit the application as soon as possible to avoid any delays in the enrollment process.

Ma in Contemporary Philosophy/Philosophy of Science is committed to creating and maintaining an educational, working, and living environment free from discrimination and harassment. *Ma in Contemporary Philosophy/Philosophy of Science* is open to all students, regardless of their national origin, sexual orientation and social status, and the Director responds to all allegations of discrimination and harassment and takes steps to ensure that each is handled according to applicable policies and legal requirements.

Prospective Students II: Application

The MA in Contemporary Philosophy/Philosophy of Science admits up to 30 students per academic year. Applications may be submitted at any time between May 21 and June 30 2024. The application period can by extended by decision of the Director.

Required application documents (to be submitted by email as a single PDF-file):

- 1. Application form
- 2. Curriculum Vitae
- 3. Undergraduate degree (or confirmation of completion of studies)
- 4. Transcript of records
- 5. Further university degrees and the relevant transcripts of records
- 6. For non-native speakers: Certificate of English language proficiency at level C1 (or equivalent)
- 7. ID or passport
- 8. One reference letter
- 9. Writing sample: A sample of academic work prepared during previous studies (3000-6000 words), or an already published paper
- 10. Letter of interest (200-400 words) stating the reasons for applying to *The MA in Contemporary Philosophy/Philosophy of Science*. The letter should demonstrate familiarity with the field of Philosophy, through the applicant's previous studies or otherwise

- Documents 1, 2 and 10 must be submitted in English. All other documents may also be submitted in Modern Greek, German, French, Spanish, or translated into English.

Prospective Students III: Selection

Selection is based on the following criteria:

a. Undergraduate degree grade (35%): "excellent" grades receive 35 points, "very good" grades receive 25 points, and "good" grades receive 15 points.

b. Evaluation of the candidates' research prospects (35%), based on the writing sample and the letter of interest: 0-35 points.

c. Academic, research, and professional achievements related to Philosophy, demonstrated on the CV (30%): 0-30 points.

For admission to *The MA in Contemporary Philosophy/Philosophy of Science*, it is necessary to obtain at least 55% of the total number of credits (i.e., at least 55 credits).

Towards enrollment

After receiving the Letter of Acceptance, prospective students are advised to **promptly** undertake the following steps:

1. Visa: Students who are not citizens of the European Union, Iceland, Norway, Switzerland, or Lichtenstein must apply **immediately after acceptance** for a Visa D 1.1 at the Greek consulate in their country of residence.

Obtaining a visa at a Greek consulate can be a lengthy and potentially challenging process; some of you might prefer to utilize the services of <u>https://www.gvcworld.eu/page/about-global-visa-center-world-gvcw</u>, which supports countries such as UK, China, or Russia.

2. Degree validation: Degrees issued by foreign universities should be officially Apostilled/ Certified. The authenticity of degrees from foreign institutions can be verified through one of the following methods:

a. APOSTILLE stamp for countries that have ratified the Hague Convention;

b. certification from the local Greek Consular Authorities for countries not part of the Hague Convention;

c. verification via a link that allows confirmation of the authenticity of the title by the issuing authority;

d. electronic confirmation of authenticity using a QR CODE issued by the degree-awarding institution.

3. Health Insurance: If you are not an EU citizen, you will need health insurance (if you need a visa, you must present the health insurance at the Consulate); prices start from only €60 per year. EU citizens should obtain and present a European Health Insurance Card.

4. Registration Form: You will find it on the website of the Program.

5. Fees: Successful applicants should pay the first installment of the tuition fee (€1350) between August 1-10 and promptly provide proof of payment to the Secretariat. In case of non-payment of the first installment or non-enrollment of one or more successful applicants, their spot will be offered to those next in line.

The second installment of the tuition fee (\leq 1350) must be settled between January 1-10. In case of extension of the duration of study, study fees of five hundred euros (\leq 540) are foreseen for each additional semester of study.

To initiate the enrollment process, please submit copies of items 1-4 to the Secretariat between September 1-10 (item 5 should have been submitted by August 10). The enrollment procedure will be concluded in September, with guidance from the Secretariat.

6. Tuition Fee Waiver: Greek Students who meet the financial or social criteria and the conditions for excellence during the first cycle of studies, are exempt from tuition fees, in accordance with the applicable legislation. This exemption is granted for participation in a single program of studeis. In any case, the exempted students do not exceed the percentage of thirty percent (30%) of the total number of potentially exempted students admitted to the program per academic year. The application for exemption from tuition fees is submitted after the completion of the selection process for the students of the program. The financial situation of a candidate is in no case a reason for non-selection to the program. Those who receive a scholarship from another source are not entitled to an exemption, nor are citizens of non-EU countries. The examination of the criteria for exemption from tuition fees is carried out by the Program Committee. and a reasoned decision is issued to accept or reject the application.5 Since the current legislation sets an age criterion, it is recommended, for reasons of good administration and equal treatment, that the date of birth of the students be considered the 31st of December of the year of birth. The members of the E.E.P., E.D.I.P., E.T.E.P. categories, who are accepted as supernumeraries in accordance with provision 3.3 of this regulation, are exempt from paying tuition fees. In the event that they simultaneously attend a program of the University, members of the same family up to the second degree of consanguinity by blood or by blood, it is possible to provide a reduction in the tuition fees paid by 50%.

Getting Ready

Successful candidates are advised to thoroughly review the <u>NKUA Concise Guide for international students</u> and follow the procedures described there. Several key points merit particular attention:

- 1. Housing: Determine your preferred neighborhood(s) in the city of Athens for residence and establish contact with a reputable agent.
- 2. If you opt not to secure accommodation remotely, arrange for temporary lodging for your initial days in Athens.
- 3. Plan to arrive in Athens at least one week before classes start.
- 4. Attend the teleconference meeting scheduled around September 20th. During this meeting, you will receive guidance on how to apply for your new email address (@uoa) and access to the university's electronic services. To complete this process, you will need your 13-digit Registration Number. After the meeting, kindly sign the application and send it to the Secretariat. Your access will be granted within one to two days. If you miss the meeting, you will have to apply by yourself here: https://webadm.uoa.gr/katsika/users/src/index.php.

Upon arrival in Athens

Students should once more carefully study the <u>NKUA Concise Guide for international students</u> and follow the procedures described there. The most important things to do after arriving in Athens are as follows:

- 1. Come to the informal meeting with the Director
- 2. Apply here for your student ID: <u>https://academicid.minedu.gov.gr/</u>.
- 3. Register at <u>https://eclass.uoa.gr/index.php?localize=en</u> and enroll in the classes.
- 4. Visit the <u>Secretariat of the Program</u> and complete your enrollment; bring with you a certified copy of your undergraduate degree and your passport.
- 5. Find permanent accommodation.
- 6. Buy a SIM-card.
- 7. Obtain a Tax Identification Number (AΦM), if necessary.
- Obtain a residence permit, if necessary.
 Postgraduate students from outside the EU who are holders of a D1.1 Visa with an annual duration need to apply for a residence permit **only** if they want to work alongside their studies in Greece.
- 9. Open a bank account if you wish to do so.

The Calendar for the academic year 2024-25:

Personal Tutor

1. Aim

The Personal Tutors, in collaboration with the Student Support Services of the National and Kapodistrian University of Athens, offer advice and support to the students with a view of facilitating their integration in the Postgraduate Program; they provide information to students on issues pertaining to their course of studies and their professional career; they pay particular attention to, and provide extra support for students facing personal, family or related difficulties that may affect their academic performance. Personal Tutors expend special effort in suggesting or providing solutions to crucial problems that might arise. However, they are not in a position to ensure in advance that all problems will be successfully resolved.

2. Mode of Operation

During the first week of the Winter Semester, the Program Director, after consultation with the academic members participating in the Program, assigns a Personal Tutor to each registered student. The Personal Tutor meets (in person, or online) each student, on a one-to-one basis, at least once during each academic semester, advises and supports the student on issues of course attendance, of choice among available courses, and of general academic prospects. The Personal Tutor bears the responsibility of monitoring the student's academic progress. During the Summer Period, the Personal Tutor's tasks are taken over by the Dissertation Supervisor.

3. The Role of Personal Tutor

The Personal Tutor is responsible for all of the following:

a) Support in facilitating the students' smooth integration in the Program during their first Semester of studies.

b) The content of courses, the participation in workshops, the optimal use of the Departments' infrastructure, evaluation methods for each course, encouragement to students for participating in progression tests, exercise sets, supportive tutoring where applicable, with the overall aim of enhancing a student's understanding and of securing the successful completion of courses a student might find challenging.

c) The content of compulsory and of elective courses, informed choice of courses that will reduce the possibility of failure at the exams, so that the student's choices are attuned to the student's specific interests and academic capabilities.

d) Discussion of the exam results.

e) Choice of Dissertation Topic.

f) Career Prospects (opportunities in the public or private sector, free-lance employment, working abroad).

g) Discussion of any issue that might create obstacles to the successful completion of the program of studies.

h) Issues about the Teaching Faculty.

i) Providing information about the University Student Support Service.

The Personal Tutor may also invite a student for a consultation meeting in case that is requested by a faculty member who assesses the student's performance as problematic (continuing absences, suboptimal results in course tasks).

In exceptional circumstances, and following upon a well-grounded request by a student, a different Personal Student may be assigned to that student.

4. Protection of Personal Datα

In fulfilling the tasks, specified under sections 2 and 3 above, the student's personal data and confidentiality are fully protected, as determined by law; the protection is in place both during and after the completion of Personal Tutor's tasks.

The Courses (2024-2025)

Parallel scientific engagement:

Athens is a vibrant city – also in terms of doing philosophy. Conferences, series of talks, informal reading groups etc. are organized by the various university departments, societies, circles or groups.

Registered students are expected to attend the Inaugural Conference of the MA Program, which takes place in the main venue of the University of Athens on 26th and 27th September 2024: "Contemporary Philosophy meets Philosophy of Science: Trends and Perspectives"

The Master's Thesis

In consultation with the Director, graduate students apply for the preparation of their Thesis during the month of April. The application includes the following: proposed title of the Thesis, supervisor's name, and a summary of the proposed Thesis.

Next, the Steering Committee appoints the supervisor and the other two members of the examination committee for each student's thesis. The maximum number of theses that each professor can supervise is set at three (3) per year.

The Thesis must be original, and possess a research-oriented character. The title of the Thesis can be changed upon the student's request and with the consent of the supervisor.

Writing Guidelines: The Thesis has a length of 20,000 words. This word count does not include the bibliography and possible appendices. The main text must be written in a font of the student's choice, size 11 or 12", with 1.5 spacing and full alignment. Footnotes should be in size 10" and single-spaced.

In order for the Thesis to be approved, the student must defend it before the examination committee. The work is graded by the committee members immediately after its defense.

Students are not obliged to remain in Athens during the Summer Term. You can write your Thesis wherever you prefer and electronically submit it by Sept. 30.

Your dissertation should in the first instance be submitted to the Secretary of the MA. After the successful examination of your dissertation, the final copy should be uploaded to the University repository of postgraduate dissertations. Assessment

Professors delivering each module will decide upon the method of assessment which can be based on, solely or a combination of, oral or written examinations.

The assessment requirements for each course unit (e.g. whether there will be a presentation or not, whether you will have to come up with your essay question, etc.) are specified in the individual course guides. Please make sure that you carefully read the course guide available on the MA website (alternatively, click on the course titles above to be prompted to the relevant pdf).

Essay and Coursework Submission

Format

- The main text must be written in a font of the student's choice, size 11 or 12", with 1.5 spacing and full alignment. Footnotes should be in size 10" and single-spaced.
- Pages must be numbered and your ID number and the course code must appear on each page.
- The total number of words (excluding the bibliography/final list of references, but including any footnotes) must be printed at the end of the essay.

Referencing and Bibliography

Students can use any form of referencing, so long as they consistently provide all the relevant citations and reference details. The most common styles are *APA*, *MLA* and *Chicago* so choose one and use it consistently. Essays and presentations should have a list of references and sources consulted and used in the assignment.

Marking

Marking is on the scale of 1-10 (including halves, 7.0, 7.5, etc.) with a minimum passing mark of five out of ten (5/10). Marks are usually released four (4) weeks at the latest after essay submissions or completion of any other form of examination. Guidelines for Assignments

Whether it is a presentation or an essay, professors will guide students to prepare their assignments. Guidelines will depend on the specific needs of the assignment and the course, but in general, students can discuss a plan of their assignment with the course tutor at an appropriate stage and receive feedback. This is an integral part of your learning process and requires your active participation to make the most out of it.

How to make use of your feedback

The purpose of written feedback is to (i) understand how the tutor marked your assignment and (ii) to help you improve your assignments and marks in the future.

Feedback will not only be negative, but also positive, so make the most out of it by preparing yourself on what you should and should not do in the future. It is important to improve yourself by addressing any drawbacks in your work but also by reflecting on what you did well.

Criticism will usually be in the form of recommendations or suggestions, and it is aimed to be constructive rather than dismissive.

Although the comments may seem to relate only to the piece of work, the general underlying points, such as having structured content, presenting clearly, and having a worked argument in the essay, will be important for other assignments in the future.

Some further tips

The mark of the assessment is what a student would look at first but even if it is not what you had expected, read the feedback to learn from it and help you improve more generally.

Read the feedback once you receive it and come back later when reflecting on how to prepare your next assignment. This enables you to consider the comments and suggestions more dispassionately and make use of them constructively.

In case you do not understand the feedback and need more information or even more help on how to improve your work, arrange a meeting with your module tutor in their office hours.

You may also find it helpful to share your experiences and discuss parts of the feedback and the general underlying points with your fellow students.

Essay preparation

The main aim of an essay is to improve your skills in structuring a piece of work and constructing an argument. As seminars progress, give yourself some time to think about a topic that you find interesting but also manageable since you may have to research different essays or prepare for an exam in the same semester. To prepare for essay writing, meet your tutor to discuss a plan you have drafted that may include a topic and a basic structure of the essay.

Writing the introduction may be helpful as you progress with your essay when you have a clearer view of the topic and your arguments. You may find it helpful to revise your introduction a couple of times as you are revising your essay. This will be beneficial because it crystallizes the main points of the rest of the essay. Remember that the introduction is the first impression and prepares what follows in the rest of the essay, but do not use more time than revising the main sections.

The main body of the essay is the part you want to put more effort into. Writing as clearly as you can will not only help make the essay more accessible to the reader but will also help you to structure your sections more easily. Don't forget that the main body should consist of self-contained paragraphs that establish the connections necessary to reach your conclusion.

Concluding the essay is one of the last things you want to do by briefly reiterating the argument and highlighting the information used to reach the conclusion.

As with other assignments, sharing your essay with fellow students is a good strategy to highlight unclear points and improve various aspects of it, such as, how you structure your argument.

Reading your essay aloud or changing the font of your document are other ways to have different angles on your written essay and correct any mistakes. Make sure to proofread your work, but it is also advised not to endlessly refine your diction. Omitting redundant elements, writing simply but not simplistically and connecting your points smoothly are ways to achieve an apposite style.

Finally, as philosopher Peter Lipton wrote in his writing guide, often, the problem with philosophical writing is not "lack of originality; it is rather that the originality is not exploited". Plagiarism: Zero tolerance

When writing scientific papers in the context of individual courses, as well as the Thesis, the student is obligated to respect the copyright of the authors of the sources used and strictly adhere to the current academic rules to avoid plagiarism. Plagiarism is considered a serious academic misconduct.

Plagiarism is: a. The verbatim copying of text from any written source (published or unpublished) without placing the text in quotation marks and/or without properly citing the source from which it is taken. b. The transfer of a text with minimal phrasal changes and without making proper reference to the source from which it is taken. c. Quoting any material, even from already published studies of the author himself, without a relevant reference. In the event that plagiarism (even of a limited extent) is found, the work in which it has been committed must be graded "zero" (0).

Graduation

The Graduation takes place in November, in the presence of members of the Steering Committee, the Director of *The MA in Contemporary Philosophy/Philosophy of Science*, the Chair of the Department of History and Philosophy of Science, and, possibly, a representative of the Rector.

The text of the assurance given by the graduates is as follows (in Greek):

Τῆς μέν ἐπιστήμης ὡς οἶόν τε μάλιστα ἐν τῷ βίῳ ἐπιμελήσεσθαι κἀπί το τελειότερον αὐτὴν προαγαγεῖν πειράσεσθαι, πᾶν δὲ ποιήσειν προθύμως ὅ,τι ἂν μέλλῃ ἐς εὐσέβειαν οἴσειν καὶ κόσμον ἠθῶν καὶ σεμνότητα τρόπων, μηδ' ἐθελήσειν τἀναντία ὦν αὐτοί γιγνώσκομεν διδάσκειν μηδέ καπηλεύειν τήν ἑπιστήμην.»

The text of the oath for graduates who obtain their degree is as follows (in English):

"Of the MA in Contemporary Philosophy/Philosophy of Science", of the Department of History and Philosophy of Science, the deserving, sworn before the Chancellor and of the President of the Department of History and Philosophy of Science, I believe and confess both. Of science, as one who in life strives for the best, let him be tempted, but let him willingly do whatever comes, be it piety and worldly morals and modesty of manners. omen they do not teach or teach science. Whoever fulfills this promise, may God be my/our helper in the struggle".

For those who do not wish to take a religious oath, a simple invocation of their honor and conscience is allowed as follows: "The Master's Degree in "MA in Contemporary Philosophy/Philosophy of Science" of the Department of History and Philosophy of Science and the Department of Informatics and Telecommunications claimants, I provide to the best of my knowledge before the Rector and the President of the Department of History and Philosophy of Science this assurance. Of science, as one who in life strives for the ultimate in temptation, let everyone willingly do whatever comes to be godly and worldly in morals and modesty of manners. omen they don't teach, they don't master science".

Graduates who have successfully completed The MA in Contemporary Philosophy/Philosophy of Science but cannot participate in the Graduation in person will be able to attend and participate online.

Award of Excellence

The MA in Contemporary Philosophy/Philosophy of Science grants an Award of Excellence to the best student of each year upon successful completion of their courses and Thesis. The Award is honorary and is personally signed by the Director of the Program.

Eligibility Criteria:

1. Attainment of an average score greater than eight, considering both semester courses and the Thesis.

2. Completion of the program within the standard one-year duration.

Selection Process:

The Steering Committee evaluates students based on their average score, ranking them in descending order. The Award of Excellence is presented to the highest-ranking student.

Supporting Information

Temporary Withdrawal

In the rare occasion that you like to temporarily withdraw, then, you will have to apply for a maximum of two semesters (no tuition fees will apply for the temporary withdrawal) by citing your circumstances (health issues and important personal or family reasons). The MA committee will decide on the application and if the withdrawal is granted, then, you will have to register again at least two weeks before the end date of the withdrawal.

Permanent Withdrawal

If you are thinking of permanently withdrawing you are strongly advised to consult your personal tutor/supervisor in the first instance. Please don't hesitate to discuss any issues with them. Once a decision to withdraw permanently is made, you should apply to the Department. You will need to provide your last date of attendance and select a reason for your withdrawal.

Duration of Studies

The MA is undertaken over one year on a full-time basis.

We understand that mitigating circumstances sometimes may not be available, or sometimes it can take longer to resolve any issues that you may face, so for that or any other reason, you may wish to extend your studies. This is possible but the extension cannot exceed half of the approved time of study (6 months for full-time - 18 months in total being the limit, and 12 months for part-time), but it will require extra payable tuition fees (500,00 Euros).

Exchange Programs

You can participate in international student exchange programs like Erasmus+ or CIVIS by successfully completing up to 30 credits as long as you have completed the first semester.

Pursuing a PhD

Graduate students who are considering pursuing a Ph.D. in philosophy are encouraged to consult with their PA and supervisor about their goals. It is best advised that students should develop strong academic and professional relationships with at least three members of the faculty while completing their M.A. degree requirements.

Tuition Fees

€2.700, payable in two equal installments of €1.350 each.

The Fee is payable upon registration for each semester.

Full-time students will be required to pay half of the tuition fees in the first and the rest in the second semester. For part-time students, €1080 are required per semester in the first year and the rest of €540 in the winter semester of the second academic year.

The same fees apply to all students (European and Overseas).

Extensions and Exemptions: We understand that you may find yourself in a precarious financial situation so for this reason, we can allow an extension of no more than 50% of the fees for the semester, which, however, cannot pass the end of it. In any case, full payment is a prerequisite for any participation in the exams and marks submission.


